On the basis of application for authorization to apply the mark and to repair wood packaging material in accordance with ISPM 15 of 29. May 2020, the Inspection Institute:


- verified the information contained in the application for authorization to apply the mark on wood packaging material in accordance with ISPM 15;
- verified the requisite knowledge of the applicant to carry out the treatment of wood packaging material, wood and other objects for which such treatment is required by e-test online
- checked the applicant's registered operations.

On the basis of the verified facts, the Inspection Institute assessed that the applicant is competent to apply the mark on wood packaging material in accordance with ISPM 15.

#### Supervision of authorized registered operators

The Inspection Institute shall supervise the authorized registered operators at least once per year in order to control them and to ensure that they treat and mark wood packaging material, wood and other objects, as appropriate, in accordance with Article 96 Par. 1 and Article 97 of Reg. EP and Council (EU) 2016/2031 and comply with the established conditions.

### Cancellation of authorisation to apply the mark in accordance with ISPM 15

If the Inspection Institute establishes that the authorized professional operator is not complying with the requirements for applying the mark and repairing in accordance with ISPM 15, it immediately takes the necessary measures to ensure that the non-compliance of those provisions persists.

If the Inspection Institute has taken such measures other than the withdrawal of the authorisation to apply the mark in accordance with ISPM 15 and the non-compliance persists, the Inspection Institute will immediately withdraw the assigned authorisation.

Authorisation to apply the mark in accordance with ISPM 15 is granted to an indefinite period of time.

Applicants may re-apply for authorisation to apply the mark and to repair wood packaging material in accordance with ISPM 15 at any time. The number of applications and their possible rejections are not defined by law.

On the basis of an application for authorisation to apply the mark and to repair wood packaging material in accordance with ISPM 15, which was accepted, after examination the Inspection Institute found that all the statutory requirements specified in the application were fulfilled and an authorisation was issued to the applicant.
